A fully adjustable Detonator Adapter is provided to securely hold a detonator in place (detonator not included).

EZCORE II™ 1000 TACTICAL DISRUPTER has been proven effective at disrupting suspicious targets containing quantities of explosives in a controlled manner with minimal collateral effects. One or more **EZCORE II™ 1000 TACTICAL DISRUPTERS** can be robot or hand deployed and fired singularly or simultaneously to effectively disrupt larger sized terrorist devices while utilizing smaller amounts of explosives all within the operational response time typically available to responding Bomb Technicians.

Pourable binary explosive core load provided – no need for additional explosives. Non-explosive for transport and storage. Flexible shipping worldwide by FedEx, air cargo, truck freight and ocean freight. Becomes a safe, reliable, tactical disrupter instantly when loaded. Fully deployable packaging that is ready for detonator insertion.

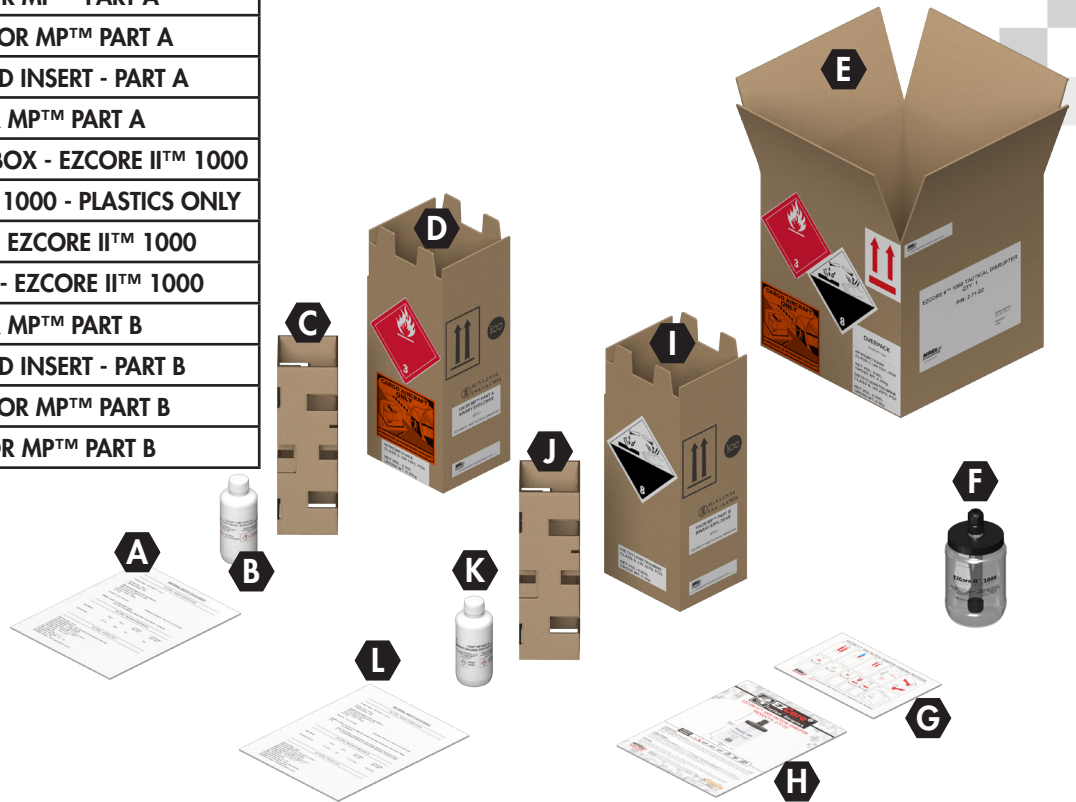
